MULTI-CRAFT CORE CURRICULUM END USER LICENSE AGREEMENT (EULA)

PLEASE READ CAREFULLY BEFORE USING THIS PRODUCT: This End-User License Agreement ("EULA") is a legal agreement between you and North America's Building Trades Unions ("Licensor") that governs your use of the Multi-Craft Core Curriculum ("MC3" or the "Work"). Licensor has granted a license to the entity providing the MC3 instruction to you, portions of which may be made available to you as a student in the course for use online and/or in hard copy.

LOGGING INTO THE MC3 LEARNING MANAGEMENT SYSTEM OR TAKING ANY STEP TO INSTALL OR USE THE WORK CONSTITUTES YOUR ACCEPTANCE OF THE USER AGREEMENT, BY WHICH YOU (1) REPRESENT THAT YOU ARE OF THE LEGAL AGE OF MAJORITY IN YOUR STATE, PROVINCE, OR JURISDICTION OF RESIDENCE AND (2) AGREE TO BE BOUND BY THE TERMS OF THIS EULA.

- 1. **Grant of License.** Licensor grants you a non-exclusive right to the Work provided you agree to and comply with all terms and conditions of this EULA. This license permits one specific natural person to access and use the Work. This is not a seat- or session-based license. Once a natural person begins use of the Work, the license is permanently associated with that named natural person and no other person may use the Work without procuring from Licensor, another license for that other person.

- 8. **Term and Termination.** This EULA is effective unless terminated or rejected. This EULA will terminate upon your completion of the MC3 course. This EULA will also terminate immediately and without additional notice in the event you breach this EULA and/or fail to comply with any term or condition of this EULA or if Licensor terminates its license agreement with the entity teaching the Work to you. In such event, you must immediately stop accessing the Work, and destroy all copies of the Work and all of its component parts in your possession or under your control. The parties agree that this EULA is deemed to have been made in the District of Columbia. Each party waives a jury trial in any matter arising out of or relating to this EULA.
- 14. **ENTIRE AGREEMENT.** This EULA is the entire agreement between Licensor and you relating to the Work and it supersedes all prior or contemporaneous oral or written communications, proposals and representations with respect to the Work or any other subject matter covered by this EULA.
